ORDER OF JUDGMENT

The jury having returned a verdict in favor of the Plaintiff, Albert Snyder, and against the Defendants, Fred W. Phelps, Sr, Westboro Baptist Church, Inc., Shirley L. Phelps-Roper, and Rebekah A. Phelps-Davis on October 31, 2007, it is this 2nd day of November, 2007, HEREBY ORDERED:

- Judgment is entered in favor of Plaintiff Albert Snyder against Defendants Fred W. Phelps, Sr., Westboro Baptist Church, Inc., Shirley L. Phelps-Roper, and Rebekah A. Phelps-Davis, in the amount of \$ 2,900,000.00 (two million, nine hundred thousand dollars) in Compensatory Damages as to Counts II (Invasion of Privacy-Intrusion upon Seclusion), IV (Intentional Infliction of Emotional Distress), and V (Civil Conspiracy) of the Amended Complaint.
- 2. a. Judgment is entered in favor of Plaintiff Albert Snyder against Defendant Fred W. Phelps, Sr., in the amount of \$2,000,000 (two million dollars) in Punitive Damages consisting of \$1,500,000 (one million five hundred thousand dollars) as to Count II and \$500,000 (five hundred thousand dollars)

as to Count IV.

- b. Judgment is entered in favor of Plaintiff Albert Snyder against Defendant Westboro Baptist Church in the amount of \$2,000,000 (two million dollars) in Punitive Damages consisting of \$1,500,000 (one million five hundred thousand dollars) as to Count II and \$500,000 (five hundred thousand dollars) as to Count IV.
- c. Judgment is entered in favor of Plaintiff Albert Snyder against Defendant Shirley L. Phelps-Roper in the amount of \$2,000,000 (two million dollars) in Punitive Damages consisting of \$1,500,000 (one million five hundred thousand dollars) as to Count II and \$500,000 (five hundred thousand dollars) as to Count IV.
- d. Judgment is entered in favor of Plaintiff Albert Snyder against Defendant Rebekah A. Phelps-Davis in the amount of \$2,000,000 (two million dollars) in Punitive Damages consisting of \$1,500,000 (one million five hundred thousand dollars) as to Count II and \$500,000 (five hundred thousand dollars) as to Count IV.
- 3. Any and all prior rulings made by the Court disposing of any claims against any parties are incorporated by reference herein, and this Order shall be deemed to be a final judgment within the meaning of Fed. R. Civ. P. 58.
