## **INFO-CULT TODAY**

The principal means by which people contact us is by phone, even with the increased use of the internet. In the past, most requests were received by phone and by mail. Over the last few years mail requests have diminished to a trickle while emails have replaced it.

As the only center of its kind in Canada we are regularly called upon by, among others, the media for information and or interviews, by high school and college students doing a project; university students working on their masters or doctorates; professionals (mental health, legal, etc...) seeking information to help with a client or as a referral.

Those types of calls are only a small part of what Info-Cult responds to on a daily basis. Most of the requests we receive come from:

- Individuals concerned about someone close to them who is involved in what they believe is a "cult". Their concerns often stem from the dramatic personality change they have seen in their family member or friend. They call looking for information, and assistance in dealing with their situation;
- Former members who have recently left their group. This includes those who are second generation former members (born or raised in the group);
- Former members who have left a number of years ago and find themselves in a situation where their experience continues to have an impact on their lives;
- Members of groups who are starting to have doubts about their involvement or just want to know our views on their group.

We receive hundreds of these types of calls every year.

The groups we receive requests about vary from being religious to therapeutic in nature and from large international ones with hundreds to thousands of members to local groups with relatively few members. Every caller's concerns are dealt with individually. Every case is unique and complex though people often wish, when calling, for a miracle solution.

We are not miracle workers; however, in just about every instance we were able to provide at least support, referrals, information or some help that proved of assistance to them.

## EDUCATION AND AWARENESS

#### Article

*"Perdus dans la controverse entourant la polygamie"* is an updated and translated article on polygamy by Michael Kropveld and Michael Langone. Similar to the **English version** the article comments on recent events in the media about polygamy, to highlight both our organizations concerns about the emotional, psychological and other needs that former members of closed high demand groups face once they leave or are kicked out.

### Media

Info-Cult staff and board members are approached on an ongoing basis by the media for background information or for interviews on "cults" and related subjects, and often in response to a specific situation.

Two situations of note among others in the last few months concern the **Mission de l'ésprit saint located in the region of Joliette, Quebec and the case of Nathalie Gettliffe**. These two situations may appear different but have a feature in common. The decision to take the law into your own hands in order to achieve one's perceived goal – save the children.

### Mission de l'esprit saint

The Mission de l'esprit saint is a group founded in Quebec in 1915 by Eugène Richer a former Quebec policeman. In 1970s the Mission splintered into a number of groups with the same name. This case involves the Mission in the region of Joliette a tightly run and closed group which has been operating their own school for years without a government permit. For the last couple of years the government has attempted to get the Mission to conform to the law. The group views society and its structures as evil and corrupt and believes that their way of life is the only way to live.

This group's case has focused considerable attention on the issue of illegal schools in the province.

Since 1982 Info-Cult has received about 320 inquiries concerning the different Mission groups. Many of the callers have been families concerned about loved-ones who've joined the group, former members who've have left, mental health workers, lawyers and the media. A significant number of former members were born and raised in the Mission and for many the lack of adequate education is one important factor that confronts them in their attempts to integrate into a world very different from their past existence. One former member in describing his experience stated "I'm an immigrant in my own country". We don't believe that a resolution to this the problem will be simple. It will require an understanding of the group's views as well how it reacts to the outside world.

#### Nathalie Gettliffe

The second case concerns Nathalie Gettliffe who is in custody in British Columbia, for kidnapping her two children. She has pleaded guilty to the criminal charges and was sentenced to 16 months in jail minus the 10 months she has already served. She has been in prison since April 2006 when she was arrested upon her return to Canada to defend her doctoral thesis at the University of B.C.

Ms. Gettliffe claims she took her children to France in 2001 to remove them from the influence of Scott Grant, their father, because of his activities in the International Churches of Christ – (ICC) a group that is considered a "cult" in France.

In a recent civil ruling in British Colombia reported on November 14, 2006 the judge indicated that interim custody of the two children is to remain with the father.

This story of Nathalie Gettliffe has provoked an intense public reaction in France and Info-Cult has received numerous requests for information about the ICC, its status in Canada and our views on this case. We have frequently stated, among other concerns about this story, that the coverage given the case may have already had a detrimental impact on those who supposedly were to be protected – the children.
